C1 Seat Adjuster Safety Hazard

James Dean is remembered as a cultural icon of teenage disillusionment and social estrangement, as expressed in the title of his most celebrated film, Rebel Without a Cause (1955), in which he starred as troubled teenager Jim Stark. The film is set in post-World War II California complete with hot rod lore for flathead fans.

In one of the most memorable scenes in the movie, Buzz Gunderson (played by Corey Allen) manipulates Jim into a dangerous game of chicken, in which two stolen cars will be raced towards a cliff above the Pacific Ocean. The winner is determined to be the last one to jump out before the cars go over the cliff. The friends of Buzz and Jim line their street rods up on both sides of the run with their headlights on, illuminating the fateful course. Natalie Wood is standing ahead and between the

cars and starts the racers off by dropping both arms. Dennis Hopper and Sal Mineo watched their man Jim nervously from the sidelines.

As they approach the end of the run, Buzz gets a strap from the sleeve of his leather coat stuck on the door handle, trapping him inside the `41 Chevy coupe as it plummets over the cliff. The look of terror on Buzz Gunderson's face as his car speeds toward the cliff edge while trying madly to free himself is unforgettable.

I too had a similar look of terror on my face behind the wheel of our 1960 Corvette: in our own driveway! Our driveway has a slight grade towards the street. Enough so that an unbraked vehicle will roll towards the street with no mechanical assistance. Typically, when I take the Corvette out for a run, I will back our truck up (from its normal parking spot in the driveway behind the Corvette), one car length to allow clearance to get the Corvette out by angle backing it out of the garage stall. Once the Corvette has cleared the garage door, I set the emergency brake, jump out of the still idling car, and manually close the garage door with the car door still open (See Photo 1).

On this day, I backed the Corvette out of the garage, opened the car door, turned to get out to close the garage door and noticed that the Corvette was rolling toward the street and my open driver side door was on a collision course with my pickup bumper. I needed to get my left leg back in the car, get square in the seat, and reset the parking brake. I tried to bring

my left leg back in and rotate in the seat but realized that I could not move my right leg. As the car continued to roll towards a collision with my truck, I thought, "I can't move my right leg! What the hell!" "I Can't Move My Right Leg!" "I CAN'T MOVE MY RIGHT LEG!" Visions of Buzz struggling to free his jacket strap flashed in front of my eyes. I could not even close the car door to avoid contact because I could not get my left leg off the driveway pavement and back into the car because of interference from my right leg. Sitting sideways in the seat I finally shut the engine off and jammed the transmission into first gear to stop the car from rolling. I had one foot to spare before the imminent door/bumper collision.

When I was getting out of the car, the open pant leg cuff on my Levi's slipped between the front of the seat and over the seat adjuster lever (See Photos 2 & 3).



At the time, I had no idea what was holding my right leg. It was like I was paralyzed for a moment. I could not move my right leg forward and I could not move it towards clutch and brake pedals. Add the pressure of an impending disaster and over the cliff you go. Once the car stopped rolling, all things became clear. My leg freed up easily and I was able to move the Corvette to the middle of the of the driveway and close the garage door. I tried to recreate the circumstances leading to the pinning of my leg and could only accomplish this with great difficulty. My main purpose in writing this is to give our membership a headsup so they do not freeze like I did and to be aware of this possibility in order to prevent it from happening.
