His second presentation was about paint or the lack of paint on the exhaust manifolds and around the exhaust ports on the block. He

included historical photos from the factory's engine test stands.

Jeff currently has Gary Beaupre's '66. It is an original paint car. Jeff showed slides after he lightly buffed the paint. The "distinctness of image" was obvious. He was impressed by how shiny the paint was and the variations of sheen or dullness in various spots for how well the car has been maintained.

Open Discussion:

Glorie McNay made her plea to the members to bring donations for the traditional raffle she conducts at the Spring Meets to her on Friday.

Jeff's leadership is taking off with his asking others to share slides of their car projects, or simply interesting pictures of your cars. This really piques a lot of conversation and sharing information.

Judging "CE" Blocks By Dave Houlihan

Figure 1 is from a "CE" engine currently resting in a 1971 Corvette. You'll notice, no VIN Stamp, and nothing that looks like an Assembly Stamp we're used to seeing – although pretty nice broach marks. What are "CE" engines and how would they judge?



"CE" stands for "Chevrolet Engine" – Not "Counter Engine", not "Counter Exchange", and not "Crate Engine". All GM Divisions had similar engine designations: C-Chevrolet, B-Buick, L-Oldsmobile, P-Pontiac, and C-Cadillac. That "E" for engine was also accompanied by a "T" for Transmission. i.e. "BT" – "Buick Transmission". Intention was to help beancounters assess warranty usage and costs. Some sources indicated that all Hydra-Matic transmissions were coded "H" regardless of GM Division.

These "CE" designations first showed up around 1968 with GM's 5 year/50,000-mile warranties. By 1976, these drivetrain warranty designations were replaced by standard assembly stamps.

Typically, you will see stampings of "CE" followed by a six-digit numeric. Decodes as GM Division / Component / a single digit Year / five-digit serial number. e.g. Our Figure 1 example CE363700 would decode as Chevrolet Engine / 1973 / Serial 63700. Note: Year Digit is year block was stamped, not model year of vehicle installed.

A little more serial number detail: our Figure 1 engine in question is a 454 ci from Tonawanda. NY. To avoid serial number duplication, each GM foundry was assigned a range of serial numbers. Tonawanda was assigned serial numbers from 50000 to 79999. (So our Figure 1 block was the 13700th Tonawanda CE unit in 1973 [63700-50000]). Note: Flint L6 assigned serial 00001 to 19999, Flint V8 assigned serial 20000 to 49999.

For example: "CE031234" would be for a Flint V8 Engine / 1970 / 11234th produced.

I don't know if Small Block "CE" engines were produced exclusively at Flint. If you know, would appreciate a heads-up. If so, you could identify Small Block or Big Block from a photo solely by serial number range. Example stamp pad photos I found had no Small Blocks in Tonawanda serial number range - but that was a very small sample size.

If a foundry ran out of assigned serial numbers, then an "A" (then "B") was added between year and serial number – with count resuming at "A+first assigned serial number". Figure 2, another big block is stamped "CE0A61217" for example.



GM documents indicate that "E" could represent a Complete Service Replacement Engine, or a Partial Engine Assembly (short block) or a basic cylinder Case and Piston Assembly, or Cylinder Case (bare block). "T" applied to both assembled transmissions and an empty transmission case. In addition to warranty replacements, it appears that you could just also purchase a "CE" for nonwarranty use.

I was not able to find anything definitive to identify warranty vs OTC purchase. Some sources stated that dealers were **supposed** to stamp a **Service Replacement** engine with date placed in service on its stamp pad. I've seen some screwy looking CE engine stamp pads with additional stampings, but don't know if they were from a Dealer or an engine rebuild shop. If you know, I'd appreciate a comment.

Figure 3 is an example of some "CE" date stampings on warranty engines - Foundry / Month / Year. For example, "T099", "T109" and "T063" – respectively Tonawanda "099" or September 1969, "109" or October 1969, "063" or June 1973. These stamps are on starter mount pads, so YMMV as to their visibility.



Well, how would this 1968-1975 "CE" stuff judge?

Our Engine Block Cylinder Cases are judged with Standard Deduction Guideline number 1. SDG#1 has a stepped approach: "A", "B", "C", and "D"

"A" is Casting Number

if Casting Number is good, then "B" "B" is Casting Date

if Casting Date is good, then evaluate both $^{\rm "C"}$ and $^{\rm "D"}$

"C" is Assembly and Date Stamps "D" is Condition of Engine Stamp Pad and Machining Marks or "Broach" Marks

Everybody starts with 350 Originality points.

First up: Casting Number and Case Configuration. For our 1968-1975 "CE" discussion:

Big Block Casting Numbers 1968 - 427 - 3916321 first design, 3935439 second design 1969 - 427 - 3935439, 3955270, 3946052 ZL1 1970 & 1971 - 454 - 3963512 1972 thru 1974 - 454 - 33999289

Small Block Casting Numbers 1968 - 327 - 3914678 1969 - 350 - 3932388, 3956618, 3970010, "010" was used thru 1980.

Take our Figure 1 engine for example: "CE363700" would indicate a block produced in 1973. This engine resides in a 1971 Corvette. 1973 Big Block casting "289" is different than a 1971 original "512". Standard Deduction #1 "A" says take 350 points and move on.

But what about those nice broach marks? Like I said, "move on".

Well, let's say the casting number was OK.

Suppose your car originally came with a 397010 block and your "CE" Small Block also has a 397010 casting number. So far, so good. And now we're at Standard Deduction #1 "B"

Suppose, unfortunately, your "CE" block's casting date is past your car's build date.

SDG#1 "B" says take 175 points and move on. (Also true if block is over 6 months prior.)

But what about those nice broach marks? Like I said, "move on".

Now, let's suppose your "CE" casting date is within NCRS' six months prior rule. [At this point stop what you're doing, and purchase a Lottery Ticket.]

Could happen, new car, enthusiastic driver, engine broken. In this case, we can now judge both "C" and "D".

Standard Deduction #1 "C" Assembly and VIN stamps. In this case, "CE" is not going to have an Assembly stamp a judge would recognize and is not going to have any VIN stamp.

SDG#1 "C" says take 50 points (25 for Assembly and 25 for VIN stamps) and judge "D".

Now we check those nice broach marks with SDG#1 "D" Stamp Pad.

Given an absence of stamp pad obscuration, and our nice normal production machining or "broach marks" we get no deduction here.

Miracle of miracle, in this instance, we've lost only 50 of our 350 points.

So What If I roll the dice, deck this block, and re-stamp?

My take on your best chance scenario: Block gets decked and you rent correct gang stamps with good characters and do a good job of restamping. Likely you pick up that 50 points lost on Assembly and VIN stamping. Also likely you now lose 38 points on "D" having destroyed "CE" machining broach marks. Net gain 12 points.

Cost: Estimate \$400 decking your block. Another \$400-600 renting proper gang stamps. Add costs for engine disassembly/assembly, gaskets, labor costs, etc and you may have gained 12 points. (Out of 4500 points in Flight Judging)

Just something to consider.

The base of the tower has the two gussets that the judges look for to assess an authentic production line 40083 pump, unlike service replacements. The flange has the correct 40083 numbers. There is no date code, which is correct for most production line 40083 pumps. Pump was rebuilt because the lower gasket does not have the "tiger stripes" as seen on originals. \$500 firm. 
